## PARTICIPATION MODE

The photo call THE TIME OF KIRON is promoted by GRAND TOUR [www.grand-touritalia.com](http://www.grand-touritalia.com) and edited by Letizia Lucignano and Luigi Arcangeli;

- Participation is free, and is aimed at both professional and amateur, foreign and Italian photographers;
- The delivery deadline for the pictures is 13th September 2020;
- The material should be sent to [redazione@grand-touritalia.com](mailto:redazione@grand-touritalia.com) specifying in the subject of the e-mail: **THE TIME OF KIRON** .
- Previously published or unpublished photographs, in black and white or in colour, with a maximum resolution of 72 dpi and size of 1-5Mb are permitted.

Individual images or thematic works can be sent:

- **SINGLE SHOT:** The participant can send one or more SINGLE images (1 to 5);
- **SHORT STORY:** The submitted work must be a project consisting of at least 6 and maximum 10 photographs.

Each author can participate in both categories. Photographs shall be taken by the participating authors, or must belong to them, to their family archive;

- In order to be published, works must indicate the author's first and last name, if available the title, the period of realization and a brief description of no more than 5-10 lines. It is also necessary to provide the author's personal Facebook and Instagram profiles, in order

to facilitate the promotion and social media sharing of the project through the use of appropriate hashtags.

- Participants must provide a release/waiver to GRAND TOUR and LightBOX for use of their images to realize the KIRONE TIME project, in full and reciprocal observance of the rules provided for privacy and copyright.

## **PUBLICATION MODE**

The selected photos and projects are going to be shared on the Instagram and Facebook profile of GRAND TOUR. Participants will be informed of the publication start date. The material received by the end of the Call, scheduled for September 13, 2020, will be selected and arranged into a virtual gallery - Art iBook- that can be browsed on the portal of GRAND TOUR.

**THE TIME OF KIRON** will seek the participation of thematic Facebook pages, magazines dedicated to photography, art and culture. The project is a collective one, so all collaborations to make this initiative as shareable and usable as possible for everyone are welcomed.

The staff at Grand TOUR are totally aware of the difficulties encountered by those working in the cultural field at the present time. At the end of its journey, **THE TIME OF KIRON**, would also like to be a collective exhibition that becomes a part of an art gallery's calendar or as part of a thematic festival. It is not currently possible to predict the outcome right now. In any case, should this goal be achieved, participation and selection modes will be communicated in advance to all the selected authors.

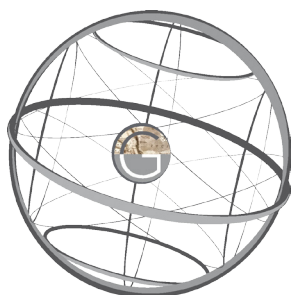
